NOTICE TO CONTRACTORS INVITATION TO BID

NOTICE IS HEREBY GIVEN that pursuant to an order of the Board of County Commissioners, County of Elko, State of Nevada, made at a regular meeting of the Board on the 7th day of April, 2021; said Board will receive separate, sealed bids for the construction of the **Elko County Roads Chip Seal 2021 Project, PWP-EL 2021-302.**

This project involves the chip sealing of Elko County roads, including Kittridge Canyon Road (CR 741A), Boyd Kennedy Road (CR 711), Corral Lane (CR 711B), Lower South Fork Road (CR 715), Jiggs Highway (CR 717), and Harrison Pass (CR 718).

The work will involve chip sealing the existing pavement surfaces and reestablishing the pavement striping and markings for each road section.

Sealed bids will be received by the Board of County Commissioners at the Office of Elko County Highway Department, 994 River Street, Elko, Nevada 89801 until 10:00 A.M. (Pacific Time) on the 10th day of June 2021. The Bids will be publicly opened and read aloud at 10:05 A.M. (Pacific Time) on the 10th day of June 2021 at the same location.

Contractors are advised that the estimated cost for the project will require contractors to comply with the requirements for a prevailing wages job. Contractors are advised to pay particular attention to Section 17 of the Instruction to Bidders in the Project Specifications to accurately calculate the wage rates contained in their bid. No pre-bid meeting is scheduled at this time.

All bids must be submitted in a sealed envelope, clearly marked, indicating the subject item of bid enclosed. Each bid must be accompanied by cash, certified check, cashier's check or bid bond for five (5%) percent of the total amount of the bid. A bidder shall possess a valid contractor's license pursuant to Nevada Revised Statutes, Chapter 624, at the time of submitting a bid. The acceptance of any bid by the Board of Elko County Commissioners, hereinafter known as the OWNER, shall be contingent upon the bidding party submitting a performance and payment bond prior to signing a contract. The successful bidder will be required to comply with N.R.S. Chapter 338 Public Works Projects. (Pursuant to NRS 338.1379, and 338.1382.)

The right is reserved by the Board of Elko County Commissioners to reject any and all bids or to accept such bid as deemed best by said Board, and to waive any technicality in the bid form of the bid.
